FROM MY HEART TO YOURS

Dear Friends,

The 2009 Annual Meeting and Conference is old news to those who attended, but still new to many sitting in the pews of our member churches. Just for your information, on the www.naccc.org Web site, you will find a half-sheet bulletin insert on some of the highlights of the meeting. You might want to copy it and use it in an upcoming Sunday bulletin. Remember, too, to go to the www.newthing.org Web site for information on the meeting.

The business sessions were filled with passionate voices, especially on the minimum contribution proposal. That proposal asked the assembly to approve a minimum Fair Share amount from all member Churches. It was one vote shy of the 2/3 needed to pass. That means that by far the majority of people attending the meeting agreed that member Churches ought to be responsible for contributing at least a minimum to the Association's Shared Ministries Fund (SMF). Several delegates spoke to the assembly and to me after that vote saying, "If we are not in favor of being told we MUST contribute, then we ought to return to our churches and make sure we are voluntarily doing so." Well stated. (An interesting statistic - you might be surprised to know that 37.5% of our churches give nothing to the Shared Ministries Fund and almost 60% give 1/2 of the Fair Share amount or less to the SMF).

I want to thank you for the confidence you showed in John Carson and me by your action on the motion to do away with Executive Terms. It was a humbling and affirming moment. My concern has always been that the measure on elimination of term limits pass, not that John and I would be included in it. You've already heard from me and other leaders as to why we were in favor of the original motion.

The Meeting and Conference evaluations that were returned and the comments that I overheard in the hallways and gatherings were very positive. **We did a new thing** and we did it well.

In recent sermons I have emphasized that actions speak louder than words, so here are a few of my "active" hopes:

I hope in this next year we will act more like people who preach and teach about a gracious and extravagant God. So many of our churches are gripped by fear these days.

I hope that your church will focus more intently on Christ's ministry on behalf of the poor and lonely this year, the poor are poorer, the lonely are lonelier.

I hope that if your church has not been in fellowship with sister churches in your area associations that you will make the effort to get them to the next gathering.

I hope that a few more of our churches will move toward consensus-building than their love of voting, which creates winners and loser.

SEMINAR OPEN TO ALL AT CENTER FOR CONGREGATIONAL LEADERSHIP



On Saturday, September 26, the Center for Congregational Leadership presents “Stewardship, Fundraising, and Financial Planning,” a one-day seminar ideal for ministers and lay people who wish to deepen their understanding of stewardship.

The event features three main presentations: “Stewards Living a God-Pleasing Life” presented by Ron Chewning of Stewardship Advisors; “Creative Fundraising” presented by Rev. Dr. Tom Richard, Executive Secretary, NACCC; and “Clergy Benefits and Saving for Retirement” presented by Richard Reese of MMBB.

The seminar takes place on the campus of Olivet College in Olivet, Mich., from 8:30 a.m. to 9 p.m. The cost is \$75 for the first participant and includes stewardship program materials and meals. The cost is \$15 for each additional member from the same

church and includes meals but not materials. Lunch and dinner will be taken in the college cafeteria.

For those seeking overnight lodging, the Comfort Inn located at 204 Winston Drive, Marshall, Mich., offers room rates of \$59 plus tax per night to Olivet College-related guests. For reservations, call 269-789-7890. Simply tell them you are attending a seminar at the college and ask for the college rate. They will need your credit card number. Amenities include free wireless internet, indoor pool, exercise room, and continental breakfast. The hotel is located just off the I-69 exit.

CONGREGATIONAL FOUNDATION FOR THEOLOGICAL STUDIES

In June, at the NACCC annual meeting, I was pleased to be able to give the delegate body their first report on the happenings of the Center. More importantly, they understood how valuable the Center can be to their home churches. The Congregational Foundation for Theological Studies supports seminarians studying for Congregational ministry. This benefits the local church by developing leadership that is uniquely Congregational, well-educated, and able to lead churches in their ministries. The Lay Ministry Training program allows laity to gain ministerial skills and knowledge. This expands the leadership resource pool for churches of all sizes and allows small churches to “raise up” suitable ministerial leadership from their own membership, knowing they can easily access a program for basic ministerial training. The Center also offers continuing education seminars on a variety of topics. Educated congregations can be more creative and adaptable to the changing culture and communities in

which they minister, reducing anxiety and empowering congregations to imagine new ways to proclaim the Gospel. Education helps congregations maintain relevancy and vibrancy. Through our History and Polity course, the Center provides a Congregational education opportunity for churches who may call a minister from outside of our tradition, helping to preserve the unique Congregational tradition of the church.

Our next seminar is September 26 (see Page 2) on stewardship and creative fundraising. CAMPAIGN CORNER *BRANCHING OUT* INTO NEW THINGS



Attendees at the recent Annual Meeting in Milwaukee learned first-hand about new things already begun through the *Branching Out* capital campaign. Amidst the prevailing economic gloom, the campaign's bright spots include:

- Opening the Center for Congregational Leadership at Olivet College in Michigan in September 2008.
- A special gift of \$25,000 from the Traditional Congregational Church in Stanton, Michigan. This gift, in memory of Dr. Victor C. Beal, Jr., was designated to support the Center at Olivet College.
- Churches continue to participate in the National Offering, which has now raised more than \$51,000 from 46 member churches.

Local church stewardship resources continue to be available through the NACCC's ongoing partnership with stewardship counsel RSI. RSI's *Forward* and *Revealed* programs help member churches grow through enhanced stewardship.

While the economic downturn has slowed campaign progress, we remain

committed to reaching its \$5 million goal. The economy will turn around and it is important that we are ready and able to respond when it does. To raise the final \$2.5 million, we are seeking individuals and churches willing to sponsor additional gifts, issue a challenge for a matching gift, or pledge a capstone gift to finish the campaign.

Here is how you can help:

FAIR SHARE GIVING

What is “Fair Share Giving”? Fair Share Giving is a voluntary, annual contribution that member churches of the National Association of Congregational Christian Churches (NACCC) give to the National Association (NA) to provide funds for the Shared Ministries Fund (SMF). The NACCC’s SMF provides the money needed to operate the NACCC office in Oak Creek, assists with publishing *The Congregationalist* magazine, provides innumerable services to member churches through its four service divisions (such as sponsoring missionaries and clergy training) and funds the Annual Meeting. Included in the SMF is everything from salaries of the staff and travel of the Executive Secretary and Executive Committee, to snowplowing, utilities, technology expenses, paper and general office supplies.

Since the NACCC doesn’t have a mandatory membership fee, it relies on the voluntary contributions of the member churches. The NACCC publishes the names of the member churches that exceed or meet the Fair Share contribution of \$10 per active member in their respective churches as recognition of their financial support. Unfortunately, not all of the 400+ member churches contribute at the Fair Share level; some don’t contribute to the NACCC at all. If all of the member

churches *did* contribute, at least at the Fair Share level, the NACCC’s annual deficits would be eliminated!

This year at the Annual Meeting a motion was made and discussion took place to create a minimum contribution *requirement* at a rate of \$5 per active member per member church, which is half of the Fair Share amount. This motion came about in an effort to encourage stewardship among member churches that don’t contribute at all, or don’t contribute at the Fair Share level. A close vote defeated this motion.

Annually, the NACCC office staff and Financial Services Committee (FSC) members contact member churches during the months of February through March to encourage the member churches to make their Fair Share donations prior to March 31. Each year the FSC thanks and recognizes all of the Fair Share Plus and the Fair Share member churches (as well as those that contribute at any level) for their contributions to help fund our National Association’s efforts and programs!

We ask that each member church prayerfully consider and submit its contribution as early as possible prior to the end of National Association’s fiscal year on March 31.
